Certification Statement

This document certifies that photographic evidence of the official election results form at Ngorika Primary polling station (018091045401103) was submitted through the Angaza platform (this submission cannot be

individually attributed to a specific contributor — see note below) on 17 July 2026 at 22:56 EAT. The submitted evidence was processed by the Angaza verification pipeline, achieving a confidence score of 55/90 (see breakdown below). To preserve its integrity, the image was stored on the InterPlanetary File System (IPFS) under content identifier (CID) QmT5NTEqLx1p17fy5B9n3Rkw67i9Tf8HxcvSxW8Fyam5N2, pinned by Angaza's storage infrastructure. A cryptographic record of this evidence was subsequently anchored on the Base Layer-2 blockchain under transaction hash 0x9eeabbd0054598d0c51e42ebcd1d808150d59e040d7ef50cf696fa0bbe47074f at 00:33 EAT on 18 July 2026. Once anchored, this record is tamper-evident: it cannot be modified without invalidating its cryptographic proof, and any such modification would be detectable through independent verification against the anchored record.

Note: this submission has no linked contributor declaration, so it cannot be individually attributed to a specific person. This affects source attribution only — see "Evidence integrity vs. source attribution vs. physical authenticity" note below — and does not affect the cryptographic integrity of the stored evidence.

Disclaimer

This certificate confirms the existence, integrity, and timestamp of the submitted evidence as recorded by the Angaza platform. It does not constitute certification of the accuracy of the election results contained in the submitted image. Verification relates solely to the authenticity, preservation, and traceability of the digital evidence.

In particular: evidence integrity (that the stored artefact is the same digital artefact originally submitted) is established via its content-addressed IPFS CID and the Base blockchain anchor above — any change would produce a different CID, detectable independently. Source attribution (who submitted this evidence) is established only when a contributor declaration is present above; otherwise this submission cannot be tied to a specific individual. Physical authenticity (that the photographed document is a genuine, unaltered polling-station form) is not established by this certificate alone — that requires the corroboration and dispute-review evidence considered alongside it.
